


I was "flagged down" by the bridge tender. He stated individuals were underneath the bridge "hanging on". I was walking down the embankment towards the underneath portion of the bridge to make contact with the individuals the bridge tender mentioned. I observed 2 white males standing next to a State of Florida No Trespassing Sign. This sign was in plain view and was posted just at the beginning of the bridge span. Officer Morgan #378 issued the lawful command for these subjects to get off of the restricted area. One of the males later became the suspect in this case.</p> <p>After Morgan issued the lawful command, the subjects walked down the hill and towards us. I asked the suspect and other involved individual if they were getting their belongings. The suspect stated no. I issued the lawful command for the suspect and involved other to get their belongings and leave the area. The suspect stated "Fuck no cop". The subject turned to walk away. I told him to "Come here". This lawful command was issued 3 times. The suspect refused to comply. I ordered the suspect to sit down. Again, he refused to comply. Ofc. Morgan approached the male and attempted to place him in custody by taking hold of the suspect's right arm. The suspect turned and began pulling, tensing and pushing. The suspect and Morgan began a physical struggle. I attempted to gain control of the suspects left arm. In doing so, I pushed the suspect and Morgan to the ground. While on the ground, the suspect continued to defeat our attempts to place him under arrest. He was issued the lawful command to put his hands behind his back. He was also issued the command to stop resisting. He refused to comply. He continued to attempt to pull free from our grasp. The suspect continued tensing his</p>

<p>arms. He continued to push and struggle. At one point, the suspect used his right knee and struck Morgan in the right side of the head.</p> <p>I was able to gain control of the suspects left arm. Morgan was able to gain control of the suspect's right. His hands were placed behind his back. Morgan placed handcuff restraints on the suspect's wrists. Once secured, the suspect stated "Take those badges off, I will fuck you up".</p> <p>Once the suspect was secured, he was rolled on his left side in the recovery position. I asked the suspect his name. He refused to identify himself. I asked the suspect if he was injured or requested medical attention. He did not respond in a positive or negative. The suspect was assisted to his feet and secured in the back of a marked patrol vehicle. The suspect was transported to Jupiter Medical Center for medical clearance. After receiving medical clearance, the suspect was transported to the Jupiter Police Department for processing. He was later transported to the Palm Beach County Jail. This concluded my investigation in this matter. My BWC was activated and captured this event. It was dislodged by the suspect and fell to the ground and under our bodies during the physical altercation. However, audio was still captured.</p>
