Other Observations:

I had to instruct Serratos-Alarcon several times to stand with his feet together during this roadside. Serratos-Alarcon moved his head while following the stimulus light after being instructed to keep his head still. Serratos-Alarcon did not follow the stimulus light continuously as instructed.

WALK & TURN:

Serratos-Alarcon swayed while standing still. Serratos-Alarcon did not remain in the instructional phase position and lost his balance several times. Serratos-Alarcon used a nearby building wall for balance by placing his left hand against the wall. Serratos-Alarcon used his arms for balance and stepped of the line several times. Serratos-Alarcon walked ten steps for each series but was only instructed to walk 9 steps on each series. Serratos-Alarcon did not touch heel to toe on several steps.

ONE LEG STAND:

Serratos-Alarcon swayed while standing still. Serratos-Alarcon stated he had a previous knee surgery on his left knee and I instructed him to stand on his right leg for this roadside. As I was giving Serratos-Alarcon instructions, Serratos-Alarcon stepped out of the instructional phase position to regain his balance. Serratos-Alarcon stated he was not comfortable performing this roadside due to his leg injury.

FINGER TO NOSE:

Serratos-Alarcon swayed while standing still. Serratos-Alarcon did not keep his feet together as instructed. Serratos-Alarcon did not keep his eyes shut during the roadside as instructed. Serratos-Alarcon missed the tip of his nose with his finger several times.

ROMBERG ALPHABET:

Serratos-Alarcon swayed while standing still. Serratos-Alarcon did not keep his feet together as instructed. Serratos-Alarcon stated he was more comfortable with reciting numbers than the English alphabet. Serratos-Alarcon stated he could count from 1-100. Serratos-Alarcon did not keep his eyes shut as instructed. Serratos-Alarcon recited the same number twice and missed a number completely during this roadside.

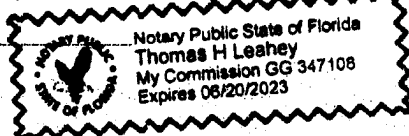

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

The following occurred in the City of Delray Beach, County of Palm Beach, FL.
On 10/09/20 at 2133hrs Sgt. Deen #943 observed a silver 2019 Mercedes GLS with FL Tag #KZMC03 attached. The FL tag expired on 09/16/19. Sgt. Deen conducted a traffic stop on the Mercedes in the rear alley behind the Hyatt Place Hotel (104 NE 2nd Ave.). Sgt. Deen met with the white male driver and identified him as Jorge Serratos-Alarcon by his NJ DL. Serratos-Alarcon was the only person in the Mercedes at the time of the traffic stop. Serratos-Alarcon was sitting in the driver seat with the vehicle engine running. I arrived on scene and met with Serratos-Alarcon. Serratos-Alarcon stated he was driving to his residence when he was pulled over.

OBSERVATION OF DRIVER:

I smelled a strong odor of an unknown alcoholic beverage coming from Serratos-Alarcon. Serratos-Alarcon's eyes were red and glassy. Serratos-Alarcon spoke with an accent and his speech was slurred and thick. During roadsides, Serratos-Alarcon was unsteady on his feet while walking and swayed while standing still. Serratos-Alarcon was polite and cooperative up till the time of arrest. Serratos-Alarcon became upset after arrest and was passive resistive by tensing his arms and not following verbal commands (i.e. put your arms behind him and to walk to the rear of my patrol vehicle).

DRIVER'S STATEMENTS:

Serratos-Alarcon stated he was on his way home when the traffic stop was conducted. Serratos-Alarcon stated he was at the Lionfish restaurant (307 E. Atlantic Ave. Delray Beach, FL. 33483) before driving home. Serratos-Alarcon stated he consumed a glass of wine and one beer while at the restaurant. Serratos-Alarcon stated he started drinking two hours prior to the traffic stop and finished his last drink forty-five minutes prior to the traffic stop. Serratos-Alarcon initially refused to perform roadsides and I informed Serratos-Alarcon of Taylor Warning. Serratos-Alarcon stated he understood and agreed to perform roadsides. Serratos-Alarcon spontaneously uttered after arrest that the arrest was excessive and he was not drunk.

ODORS:

Serratos-Alarcon had a strong odor of an unknown alcoholic beverage coming from his person.

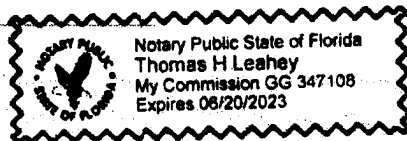
