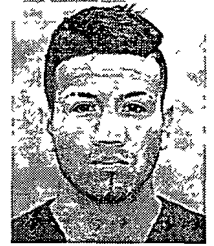

Before me this date personally appeared **PLESHER, ALEX J (PD0949)** who being first duly sworn deposes and says that on **19** day of **April**, (year) **2017** at **3900 WOODSIDE DR, CORAL SPRINGS, FL 33065** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

On 04/19/2017 at 1237 hours I was on routine patrol in my marked CSPD patrol vehicle. I was traveling south on Woodside Dr approaching the 3900 block at the posted speed of 25 miles per hour. I observed a gray vehicle heading northbound on Woodside Dr and estimated the vehicle's speed to be 53 miles per hour in a posted 25 mile per hour zone. I utilized my department issued Stalker MDR dashboard mounted radar to confirm the vehicle's speed of 53 miles per hour. As the vehicle passed me I made a u-turn and
