The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 1/10/2021, at approximately 2359 hours, at 1710 Brandon Bl. W., Brandon, FL 33510, I made contact with the defendant, who was passed out in actual physical control of her vehicle, a blue Toyota (bearing FL tag IC13TT / VIN: 2T1BU4EE9DC049248). Upon making contact, the defendant was observed to have glassy, watery, bloodshot eyes; she displayed slurred speech and I detected the odor of an alcoholic beverage. The defendant also displayed disoriented behavior and struggled maintaining her balance upon exiting the vehicle. The defendant admitted to consuming approximately 4 shots of Hennessy liquor and was given the opportunity to perform field sobriety exercises, which she did poorly indicating impairment. Subsequent to arrest, the defendant provided breath samples of .173/.169 after a twenty minute observation period. While conducting an inventory search of the vehicle, I located an unsecured firearm in the pocket behind the front passenger seat directly in front of a child's car seat. The defendant does not possess a valid CCW, which was confirmed via HCSO Operator 100. The defendant was identified via their Florida driver's license.
