 The defendant crashed into a semi in the parking lot at Dimples Cleaner, while driving a Ford Explorer 4-door (FL Tag #NJNN44). There were no injuries as a result of this traffic crash.

Officer 51874-DAVIS, BLAKE observed the DEF. behind the wheel of this vehicle and in actual physical control. He made observations that the DEF. smelled strongly of alcoholic beverage, bloodshot eyes, disoriented, and passed out.

I arrived on scene to conduct the DUI investigation, and during my observations, the defendant displayed multiple clues of impairment to include, bloodshot/glassy eyes, slurred speech, unsteady on feet/swaying, fumbling with garage door opener, and the distinct odor of alcohol emanating from his breath.

During SFSEs, the defendant displayed additional clues of impairment, and was arrested for DUI.

While at Central Breath Test, the defendant provided a breath sample, which yielded a BrAC result of .184/.185

The defendant was identified via his FL driver's license.
