The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:  
 Knowingly and unlawfully commit the offense of DUI, to wit:

The defendant was operating a 2016 red in color Ford F150 bearing Florida Tag# LCJ192, while traveling north on the I-275 northbound exit ramp at Sligh Av E. It was at that location, the defendant was following too closely and rear-ended the victims vehicle as she was slowing for the red traffic signal, causing approximately \$2,500 in damages. The listed victim and the witness identified the defendant as the driver. Upon making contact with the defendant, he was observed to have bloodshot/watery eyes, slurred speech, and the odor of alcoholic beverages was emanating from his breath. The defendant participated in FSE's and demonstrated clues of impairment. Post arrest, the defendant provided breath samples of .198/.210 BrAC. The defendant was positively identified via Florida Driver's License.
