The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was stopped for driving erratically when affiant observed his vehicle weaving back and forth in his lane, straddling the center lane divider, fail to signal when changing lanes, and stopping in the crosswalk at a red traffic signal. The defendant was driving his 2016 Jaguar 4dr, bearing FL tag #DTSS01. Upon making contact with the defendant, affiant observed he displayed multiple indicators of impairment, including: Bloodshot/glassy eyes, a distinct odor of an alcoholic beverage on his breath, difficulty dividing his attention, and an admission to consuming alcoholic beverages. The defendant exhibited several clues of impairment during the SFSEs and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .079/.081. The defendant identified himself via his FL driver's license.
