On the listed offense date, time, and location, your affiant responded to a Motor Vehicle Crash - With Injuries (HCSO Case #20-431439 / Crash Report #89432411). Upon arrival and during contact with a motorcyclist/defendant (Joseph Frem) involved, signs of impairment were detected (odor of alcohol, slurred speech, glassy eyes, and admission to alcohol consumption). Upon the conclusion of Deputy Juncal's (ABN #253879) traffic crash investigation, which was estimated to have \$1500 in property damage, your affiant notified the defendant of a transition to a DUI investigation. Miranda warnings were read to the defendant, and he provided a post-Miranda statement admitting to consumption of five (5) Corona Extra beers. The defendant further stated he felt the effects and knew he should not be driving. SFSE's were conducted roadside with multiple signs of impairment detected. The defendant was arrested on scene for DUI with property damage, and transported to CBT. After a twenty (20) minute observation period, the defendant provided two (2) lawful breath samples of .160/.158% BAC. The defendant was positively identified via his suspended Florida Driver License (Class B CDL). The witness (Jarod Mounce) positively identified under oath the defendant was the sole occupant of the motorcycle and observed him operating same.
