On the listed offense date, time, and location, the defendant (Joseph Pappas) was involved in a motor vehicle crash when he was operating his 2016 White Ford F-150 Bearing Florida Tag #LSGD50. The defendant was the at fault motorist when he rear-ended another vehicle, which subsequently pushed that vehicle into a third vehicle. Upon arrival of your affiant, indicators of impairment were immediately detected from the defendant. The witness (Krystal Mitchell) was a passenger in the first vehicle struck by the defendant and positively identified him as the person was in operation of the F-150. Upon the conclusion of Deputy R. Clark (ABN #4035) vehicle crash investigation, your affiant began a criminal DUI investigation. The defendant was read his Miranda warnings, but invoked his rights to attorney. The defendant did agree to participate in Field Sobriety Exercises, which he performed to an unsatisfactory performance. It should be noted, the defendant nearly fell asleep while standing numerous times. The defendant was placed under arrest on scene for DUI with property damage and injury. During an inventory search of the F-150, various prescription pill bottles with the defendant's name was located, along with suspected marijuana. Upon arrival on CBT, the defendant refused to provide a breath sample or urine sample. Implied Consent warnings were read to the defendant and he still refused to provide a sample. The defendant was positively identified via Florida Driver License.
