UPON MY ARRIVAL, THE DEFENDANT, LATER IDENTIFIED AS JOSEPH SIRIANNNI, WAS BEING PULLED OUT OF THE WATER BY WITNESS 2, LATER IDENTIFIED AS BRENDAN CASEY, WHO IS A LIFE GUARD. ONCE THE DEFENDANT WAS PLACED INTO HOLLYWOOD RESCUE 31'S TRUCK, THE DEFENDANT UTTERED "I JUST WANTED TO END THIS". THE DEFENDANT DID NOT SEEM TO BE UNDER THE INFLUENCE OF ANY NARCOTICS OR ALCOHOLIC BEVERAGE. IT APPEARS THE DEFENDANT WAS ATTEMPTING TO END HIS LIFE BY DRIVING HIS WHITE AND ORANGE 2D SMART CAR BEARING FL TAG #GHUE53 INTO THE LAKE AT TY PARK. IT WAS LATER DISCOVERED THE DEFENDANT WAS RENTING CAMP SITE #24 INSIDE TY PARK AND HAD BEEN IN THE PARK FOR A TOTAL OF 2 DAYS. WITNESS 1, RYAN SEILKOP, ADVISED HE WAS AT THE WATER PARK WHEN HE OBSERVED THE DEFENDANT DRIVING HIS VEHICLE DIRECTLY INTO THE LAKE. AS THE VEHICLE WAS SUBMERGING WITNESS 1 ENTERED THE WATER IN AN ATTEMPT TO RESCUE THE DEFENDANT FROM DROWNING. WITNESS 1 ADVISED HE OPENED THE DRIVER DOOR AND NOTICED THERE WERE TWO SMALL DOGS STILL TRAPPED INSIDE THE VEHICLE. WITNESS 1 ADVISED HE ATTEMPTED TO PULL ONE OF THE DOGS OUT

DEFENDANT DRIVING HIS VEHICLE DIRECTLY INTO THE LAKE. AS THE VEHICLE WAS SUBMERGING WITNESS 1 ENTERED THE WATER IN AN ATTEMPT TO RESCUE THE DEFENDANT FROM DROWNING.
WITNESS 1 ADVISED HE OPENED THE DRIVER DOOR AND NOTICED THERE WERE TWO SMALL DOGS STILL TRAPPED INSIDE THE VEHICLE. WITNESS 1 ADVISED HE ATTEMPTED TO PULL ONE OF THE DOGS OUT OF THE VEHICLE BUT FAILED DUE TO THE VEHICLE RAPIDLY SUBMERGING. WITNESS 1 ADVISED THE DEFENDANT WAS CLUTCHING THE STEERING WHEEL AND WOULD NOT MOVE HIS BODY OR ATTEMPT TO SAVE HIMSELF OR EITHER DOG. WITNESS 1 ADVISED THE DEFENDANT EVENTUALLY LET GO OF THE STEERING WHEEL ALLOWING WITNESS 2 TO PULL THE DEFENDANT OUT OF THE VEHICLE. WHEN THE DEFENDANT WAS OUT OF THE VEHICLE, WITNESS 2 WAS ABLE TO PULL HIM OUT OF THE WATER AND TO SAFETY.

RESCUE PERSONNEL WERE ABLE TO PULL ONE DOG OUT OF THE VEHICLE, HOWEVER THE DOG HAD
