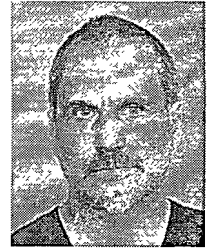

Probable Cause Affidavit

Before me this date personally appeared DIAZ, LUIS (3497) who being first duly sworn deposes and says that on 5 day of May, (year) 2017 at 3301 N PARK RD, HOLLYWOOD, FL 33021 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

A LAKE AND COMPLETELY SUBMERGED UNDER WATER.

UPON MY ARRIVAL, THE DEFENDANT, LATER IDENTIFIED AS JOSEPH SIRIANNI, WAS BEING PULLED OUT OF THE WATER BY WITNESS 2, LATER IDENTIFIED AS BRENDAN CASEY, WHO IS A LIFE GUARD. ONCE THE DEFENDANT WAS PLACED INTO HOLLYWOOD RESCUE 31'S TRUCK, THE DEFENDANT UTTERED "I JUST WANTED TO END THIS". THE DEFENDANT DID NOT SEEM TO BE UNDER THE INFLUENCE OF ANY NARCOTICS OR ALCOHOLIC BEVERAGE. IT APPEARS THE DEFENDANT WAS ATTEMPTING TO END HIS LIFE BY DRIVING HIS WHITE AND ORANGE 2D SMART CAR BEARING FL TAG #GHUE53 INTO THE LAKE AT TY PARK.

IT WAS LATER DISCOVERED THE DEFENDANT WAS RENTING CAMP SITE #24 INSIDE TY PARK AND HAD BEEN IN THE PARK FOR A TOTAL OF 2 DAYS.

WITNESS 1, RYAN SEILKOP, ADVISED HE WAS AT THE WATER PARK WHEN HE OBSERVED THE DEFENDANT DRIVING HIS VEHICLE DIRECTLY INTO THE LAKE. AS THE VEHICLE WAS SUBMERGING WITNESS 1 ENTERED THE WATER IN AN ATTEMPT TO RESCUE THE DEFENDANT FROM DROWNING. WITNESS 1 ADVISED HE OPENED THE DRIVER DOOR AND NOTICED THERE WERE TWO SMALL DOGS STILL TRAPPED INSIDE THE VEHICLE. WITNESS 1 ADVISED HE ATTEMPTED TO PULL ONE OF THE DOGS OUT OF THE VEHICLE BUT FAILED DUE TO THE VEHICLE RAPIDLY SUBMERGING. WITNESS 1 ADVISED THE DEFENDANT WAS CLUTCHING THE STEERING WHEEL AND WOULD NOT MOVE HIS BODY OR ATTEMPT TO SAVE HIMSELF OR EITHER DOG. WITNESS 1 ADVISED THE DEFENDANT EVENTUALLY LET GO OF THE STEERING WHEEL ALLOWING WITNESS 2 TO PULL THE DEFENDANT OUT OF THE VEHICLE. WHEN THE DEFENDANT WAS OUT OF THE VEHICLE, WITNESS 2 WAS ABLE TO PULL HIM OUT OF THE WATER AND TO SAFETY.

RESCUE PERSONNEL WERE ABLE TO PULL ONE DOG OUT OF THE VEHICLE, HOWEVER THE DOG HAD

Probable Cause Affidavit

Before me this date personally appeared DIAZ, LUIS (3497) who being first duly sworn deposes and says that on 5 day of May, (year) 2017 at 3301 N PARK RD, HOLLYWOOD, FL 33021 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

DECEASED PRIOR TO RESCUE'S ARRIVAL. THE DOG "KIRK" WAS TRAPPED INSIDE THE VEHICLE AS IT WAS SUBMERGING AND WAS UNABLE TO ESCAPE BEFORE DROWNING.

THE OTHER DOG "SPOCK" WAS LOCATED MINUTES LATER ON THE SHORE OF THE LAKE AND MOST LIKELY EXITED THE VEHICLE WHEN WITNESS 1 OPENED THE VEHICLE DOOR AND PULLED THE DEFENDANT FROM THE VEHICLE.

THE DEFENDANT INTENTIONALLY DROVE HIS VEHICLE INTO THE LAKE WHILE IN CARE AND CUSTODY OF BOTH SPOCK AND KIRK. THE DEFENDANT'S ACTIONS RESULTED IN THE CRUEL DEATH OF KIRK AND THE UNNECESSARY PAIN AND SUFFERING OF SPOCK AS THEY WERE TRAPPED INSIDE A SUBMERGING VEHICLE.

AN OFFICER ON SCENE WAS ABLE TO MAKE CONTACT WITH THE DEFENDANT'S SISTER IDENTIFIED AS SUSAN SIRIANNI, WHO TOOK CARE AND CUSTODY OF SPOCK. THE DECEASED DOG, KIRK, WAS RECOVERED BY ANIMAL CONTROL.

SGT VANEGAS 2191 RESPONDED TO THE SCENE AND CRIME SCENE WAS REQUESTED VIA RADIO DISPATCH. CRIME SCENE TECH BARCOMB #3343 RESPONDED TO PROCESS THE SCENE. SEE HER REPORT FOR FURTHER.

THE DEFENDANT WAS TAKEN TO MEMORIAL REGIONAL HOSPITAL UNDER THE BAKER ACT. A PATIENT HOLD WAS COMPLETED FOR THE CHARGES LISTED ABOVE. THE DEFENDANT WAS LATER TRANSPORTED TO BSO MAIN JAIL FOR FURTHER PROCESSING.
