The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 07/05/2021, at approximately 0131 hours, I responded to 41 Hw N and Falls Bl. Apollo Beach, FL. 33572 in reference to a Wrong Way Driver, call for service. Deputy Hernandez (ABN:258016) observed the white in color, vehicle (IL48UP/VIN:1VWBT7A36HC083295) traveling southbound in the northbound lanes. Deputy Hernandez conducted a traffic stop on the vehicle and made contact with the defendant, who was the driver of the vehicle. Deputy Hernandez observed indicators of impairment from the defendant. When I arrived on scene, I made contact with the defendant. I observed him to have watery/glassy eyes and the odor of an alcoholic beverage emitting from his breath. The defendant elected to perform the standardized field sobriety exercises, and doing so, I observed more indicators of impairment. At Central Breath Testing, at Orient Road Jail, the defendant agreed to provide lawful breath samples after a twenty minute observation. The breath samples were recorded at .138 and .140. The defendant was identified via Florida driver's license.
