The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 02/08/2021, at approximately 2044 hours, in front of the residence located at 2102 Valleybrook Ave, Deputy Bruce (ABN 257637) arrived on scene to a vehicle crash involving two vehicles. Deputy Bruce made contact with a wheel witness who observed the defendant exiting a silver Chevy Silverado bearing FL tag HSCQ39 immediately after the crash occurred. Deputy Bruce made contact with the defendant and observed indicators of impairment. The defendant emitted an odor of an alcoholic beverage from his breath, had slurred speech, bloodshot watery eyes, and he had unstable balance. Deputy Busatto (ABN 246672) completed the traffic crash investigation and estimated the property damage above \$9,000. The affiant advised the defendant the traffic crash investigation was complete and the affiant was conducting a separate criminal DUI investigation. The affiant read the defendant his "Miranda Warnings" from an agency issued Warning of Constitutional Rights card. The defendant invoked his rights. Standardized Field Sobriety Exercises were refused. Based on the totality of the investigation, the defendant was arrested for DUI with property damage and refused to provide two lawful breath samples. The affiant advised the defendant of the Implied Consent warning in CB-01 room in CBT, where he still refused (see video). Subsequently, I completed the Affidavit Of Refusal To Submit To Breath Test. The defendant was positively identified via a Florida DL photograph
