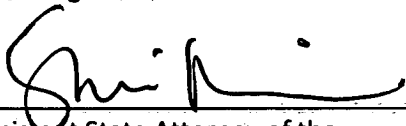

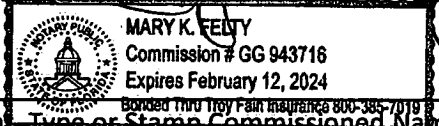

The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 First off, Mr. Andrew Forest was Baker Acted and transported by EMS to St. Joseph's Hospital South for mental evaluation. Prior to being transported to the hospital, I attempted to speak with Mr. Forrest about an incident that previously occurred. He was walking with a fishing rod in the area of Eastbay High School on Big Bend Road. I asked him to drop the fishing rod and he told me, "not" and marched away chanting spiritual things. A HCSO deputy and I grabbed the subject to safely detain him. As we were handcuffing him, he was still talking about things pertaining to God and the he was told to smash in the rear of other vehicles. He mentioned that no one ever crashed into multiple vehicles without getting hurt and that it was the grace of God. Mr. Forrest was then placed in the back of the patrol vehicle. He told the deputy and I that he was trying to save us from hell. He was placed under arrest for leaving the scene of an accident with property damage and was in the process of being transported to the Hillsborough County Jail. While Mr. Forest was seated in the back of my patrol unit, he began once again speaking on spiritual matters in referencing how God is influencing him to do things as instructed. Also, he started yelling and screaming while banging his head multiple times against the backseat cage in patrol vehicle. He mentioned that he needed to spit out the window and if I did not role the window down, he would spit in my car. As I attempted to role the window down, he had already spat on the floor. Afterwards, EMS was notified for mental evaluation. The on-duty ER Physician advised that he would proceed with the Baker Act and also Mr. Forest would be held for at least a period of 3 days for evaluation.

Secondly, Mr. Forrest was involved in five (5) different hit and run crashes while driving north on I-75 in Hillsborough County until he crashed his own vehicle into a ditch line and fled on foot. There are five (5) different troopers contributing to the events that occurred and preparing separate crash reports and traffic related charges.

First Crash:
 Vehicle 1 (V01) was traveling northbound on I-75 (State Road 93A), in the center lane, approaching MM239.
 Vehicle 2 (V02) was traveling northbound on I-75 (State Road 93A), in the center lane, approaching MM239, directly ahead of V01.
 Driver of V01 failed to stop vehicle for traffic ahead, at which time the front of V01 collided with the rear of V02.

D-2 statement: He advised that he was traveling in the center lane with an attempt to pass V01 which was initially traveling in the inside lane. Once V02 passed in the center lane, D-1 made a lane change to the center lane directly behind V02. According to D-2, D-1 intentionally struck the rear of V02 due to the acceleration of the speed from D-2's rearview mirror.

After the collision between V01 and V02, D-1 fled the scene of the accident without providing any vehicle and insurance information. V02 was relocated from area of collision to the left side shoulder, prior to my arrival.

This incident will be forwarded to the State Attorney's Office for further review/pending charges.
