The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a silver 2017 Honda Civic (FL TAG# KDCC52) eastbound on Platt St W, then northbound on Howard Av N with no taillights illuminated. During the traffic stop for the infraction, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, slurred speech, slow deliberate movements, fumbling fingers, appeared lethargic, and had a distinct odor of an alcoholic beverage stemming from his breath.
