The following incident occurred in the City of Riviera Beach, Palm Beach County, Florida and was captured on body worn camera.

On April 14th, 2020 at approximately 1330 hours, I was dispatched to 7231 Haverhill Rd. #205 (Mister Sparky Electrical Supplies) in reference to a delayed theft.

Upon my arrival, I made contact with the caller later identified Richards, Bryan (W/M DOB 10/17/78) who stated the following statement not to be taken verbatim:


Richards is the Vice President of the company. He alleges that his employee, Griggs, Joshua (W/M DOB 10/28/1972) stole \$2,700 over a two-month period via fraudulent charges on the company credit card. Griggs was issued the card by the organization as he was a manager and was to purchase Publix, CVS, and Walgreens` gift cards as incentives for employee performance. Based upon the credit card statements for February and March provided by Richards, Griggs made the following charges:

February - \$1269.40 - nine (9) transactions  
March - \$1466.50 - nine (9) transactions

When asked if Griggs was confronted, Richards stated that he and the company owner David Connolly spoke with Griggs on April 8, 2020. Richards alleged that Griggs admitted to making the charges and keeping all of the gift cards for his family saying that his family was in need. It should be noted that Griggs is the only employee with access to this card.

All emailed receipts and statement were uploaded into Evidence.com.

Richards signed the Affidavit of Complaint and was provided the case number 20-02809 and
