Anyzeski was also on probation with restrictions to remain confined to his approved residence which was not this hotel.</p> <p>Based on my investigation, Joshua David Anyzeski (age 20) knew that [REDACTED] (age 15) was under the age of 18 at the time he took her out of her home without the permission of her legal guardians and began looking for a hotel room, In violation of F.S.S. 827.04 (1) (B) and F.S.S. 985.731.</p> <p>Anyzeski also knew that he was currently on probation and confined to his approved address in violation of F.S.S. 948.06. Anyzeski also knew that he was in possession of a fraudulent Ohio driver`s license in violation of F.S.S. 322.212 (1) (A). Anyzeski was also showing an active warrant for violation of probation out of Martin County in violation of F.S.S. 901.04.</p>
