	On March 11, 2022, at approximately 2351 I was on a business check at RaceTrac 200 N. Congress Ave located in the Town of Lake Park, FL 33403. I observed a suspicious vehicle parked pump #2 which no license plate attached. I made contact with the occupants of the vehicle and noticed a temporary tag bearing (CXA8963), when ran it came back expired as of 04/2021 with no vehicle information attached. The driver provided the registration for the vehicle 2013 black Lexus ES350, the tag was valid but not attached to the vehicle.								
	When talking with the occupants later identified as Joshua Grippa (DOB 04/17/91) who was sitting in the driver seat I observed drug paraphernalia and illegal narcotics in plain sight. I has Grippa and his passenger Dawn Griffiths (DOB 01/19/1980) exit the vehicle due to having probable cause to search the vehicle. I detained both individuals and placed Grippa in D/S H. Florexil #7121 marked patrol vehicle, and Griffiths into my marked patrol vehicle. While placing Grippa into the patrol vehicle he stated, he let a buddy drive his vehicle and sated that his buddy left some rock under the driver seat.								
	During my search I found, (2) used crack pipes, and (1) clear plastic baggie containers with suspected crack cocaine inside. (1) Crack pipe was found in the driver floorboard along with the clear plastic baggie of suspected crack cocaine. (1) Crack pipe was found in Griffiths' purse that was located in the passenger floorboard.								
	Based on my investigation, I found Grippa was in violation of FSS 893.13(6)(a) - Possession of Cocaine, due to the facts he was knowingly in constructive possession of cocaine which is a controlled substance and FSS 893.1471 DRUG EQUIP-POSSESSION								
	Grippa was then placed into PBSO issued restraints which were double locked and checked for fit. Grippa was placed into the back of a marked PBSO issued vehicle, seat buckled in and transported to the County Jail.								
	The cocaine, and drug paraphernalia was seized on scene and placed into PBSO evidence.								
	The suspect crack cocaine was field tested using a PBSO issued cobalt test kit which yielded a positive result for cocaine, field tested negative using PBSO issued marquis test kit.								
	All drugs and drug paraphernalia was seized on scene and placed into PBSO evidence at District 10.								
	This case is cleared by arrest.
