Florexil #7121 marked patrol vehicle, and Griffiths into my marked patrol vehicle. While placing Grippa into the patrol vehicle he stated, he let a buddy drive his vehicle and sated that his buddy left some rock under the driver seat. During my search I found, (2) used crack pipes, and (1) clear plastic baggie containers with suspected crack cocaine inside. (1) Crack pipe was found in the driver floorboard along with the clear plastic baggie of suspected crack cocaine. (1) Crack pipe was found in Griffiths' purse that was located in the passenger floorboard.					the

Based on my investigation, I found Grippa was in violation of FSS 893.13(6)(a) – Possession of Cocaine, due to the facts he was knowingly in constructive possession of cocaine which is a controlled substance and FSS 893.1471 DRUG EQUIP-POSSESSION Grippa was then placed into PBSO issued restraints which were double locked and checked for fit. Grippa was placed into the back of a marked PBSO issued vehicle, seat buckled in and transported to the County Jail.					onstructive	e
