at approximately 12:27 AM, at 9950 11TH ST N UNIT 213, in Pinellas County did:

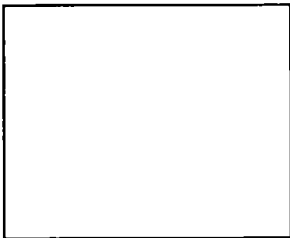
