The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On January 25, 2020, at approximately 0220 hours, on Florida Av. N. Deputy P. Campisi ABN#: 258804 observed a white 2013 Ford F-250 bearing Florida license plate#: XA5BU (VIN: 1FT7W2BT9DEB17763) traveling Northbound Florida Av. N. without any headlights on in violation of F.S.S. 316.217(1)(a). Deputy Campisi also observed the vehicle stop past the stop bar for a steady red light at the intersection of Florida Av. N. and Lake Magdelene Dr. by the length of the defendant's truck. Deputy Campisi conducted a traffic stop on the vehicle and came into contact with the defendant (driver). Deputy Campisi observed the defendant to have bloodshot and glassy eyes, slow speech, and when the defendant was reaching into his car he struck his car head on the frame of the car. The driver's side mirror was missing from the vehicle, there was a hole in the driver's side window, and the defendant was covered in broken glass. I made contact with the defendant and observed him to have bloodshot and glassy eyes, slurred speech, and I detected the strong odor of an alcoholic beverage emanating from his breath. The defendant performed standardized field sobriety exercises poorly indicating impairment. Once at Central Breath Testing, after a twenty-minute observation period, the defendant provided lawful breath samples showing a breath alcohol concentration of .141/.144. I confirmed the defendant's identity via DAVID.

Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge. For Notices to Appear, I also certify that a complete list of witnesses and evidence known to me is attached.
