| The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did<br>The defendant entered the WaWa and tried to access the beer cooler inside the store, which was locked. Ofc. Kline, who was inside the store and who observed the defendant, informed him that an employee would have to open the cooler for him. The defendant, who visibly appeared impaired and was unsteady on his feet, walked away but returned a few minutes later and tried opening the beer cooler again. Ofc. Kline again informed the defendant the cooler was locked. The defendant had glassy eyes, slurred speech and a strong odor of an alcoholic beverage emitting from his breath. The defendant, who was later identified by his Florida driver's license, then exited the store. A patron entered the store a few minutes later and informed Ofc. Kline that a subject fitting the defendant's description, and who appeared to be drunk, had just got into the driver's seat of a pick-up truck that was in the parking lot and they were concerned that he was going to drive away. Ofc. Kline made contact with the defendant, who he immediately recognized from his previous encounter at the beer cooler. The defendant was seated in the driver's seat of the truck and had the keys to the vehicle in his possession. He was the sole occupant. The defendant initially refused to hand the keys over to Ofc. Kline when he requested them, then he jumped over into the passenger seat. When I made contact with the defendant, who displayed obvious indicators of impairment, and asked him if he would be willing to perform SFST's, he refused. Defendant was arrested for DUI and transported to CBT where he was red implied consent but refused a breath test. A license query showed a prior DUI with a breath refusal in 2014. Defendant was additionally charged with the subsequent refusal.
