The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did I observed the defendant driving a white Hyundai with FL tag EAEM49 on the roadway. He was drifting side to side. He was varying his speed and almost came to a stop in the roadway for no obvious reason. He continued to drift side to side and I conducted a traffic stop based on a reasonable suspicion he was ill, tired or impaired. As I approached the vehicle the defendant put a handful of gum in his mouth. Upon contact with the defendant I could smell the odor of alcoholic beverages coming from his breath.
