On 03/13/2021, at approximately 1948 hours, at the intersection of N Dale Mabry Hwy and Lake Carroll Way, Deputy D. Randall (ABN 244931) responded to a traffic crash involving a blue Chevrolet Spark (FL tag: LYHV16) and a black Hyundai Elantra (FL tag: IGDE57). The defendant was operating the Hyundai when he failed to stop in traffic and struck the rear of the Chevrolet, which was stopped for a solid red traffic signal. The defendant then fled the scene in his Hyundai and was followed by a witness (Clifton Thayer), to the intersection of West Linebaugh Ave and Champagne Dr. Clifton Thayer and the driver of the Chevrolet observed the defendant to be the driver of the Hyundai at the time of the crash. As a result of the crash, the vehicles sustained approximately \$1,500.00 in damages. The traffic crash was investigated by Deputy Randall under HCSO case #21-165222 (DHSMV #82694642). Upon contact with the defendant, he had bloodshot glassy eyes and the distinct odor of an alcoholic beverage emitted from his breath as he spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI with Property Damage. Implied consent was read and the defendant refused to provide a lawful sample of his breath. The defendant was positively identified via his Georgia driver's license.
