The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the above-listed date and time, at the above-listed location, Deputy Calderon #247509, observed a suspicious vehicle. Deputy Calderon made contact with the defendant and observed signs of impairment. The Affiant responded to the scene, detected the defendant to have glassy and bloodshot eyes, slurred speech, and a distinct odor of an alcoholic beverage emanating from his breath. Affiant requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to perform. During the exercises, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant agreed to provide two lawful breath sample to determine his breath alcohol content (BAC). After a proper 20 minute observation period was conducted, the defendant provided two lawful samples of his breath. Breath Technician Peaguignot #255300, provided me with BAC results, and they are as follows: First BAC sample (.202): Second BAC sample (.193). The defendant received a DUI citation #A2VEH5E, which reflects the DUI charge. The defendant was identified via his Florida Driver's License.
