On March 20, 2022, the Lake Worth Communications Center (LWRCC) gave out a call (BOLO)of a vehicle traveling northbound on Interstate 95 (State Road 9) south of 10th Ave. There were several calls from an outside witness stating that this vehicle was unable to maintain its lane of travel, almost causing several accidents. The vehicle description was a black Chevy Silverado pickup truck. While traveling northbound on State Road 9 south of State Road 704 (Okeechobee Blvd) to intercept the vehicle, I observed a vehicle matching the description of the (BOLO'd) vehicle. I proceeded to get behind the vehicle in the outside lane at State Road 9 northbound just north of Okeechobee Blvd. Once I arrived behind the vehicle, I advised dispatch the Florida tag of QYUN41 attached to the vehicle and established a driving pattern on the vehicle. I paced clocked the vehicle with my patrol car (FHP2047) traveling at a speed of approximately 55 mph in a 65 mph zone for approximately .5 mile. The vehicle traveled off the roadway towards the right outside shoulder, almost resulting in a collision with the right outside guardrail. The black pick-up truck then traveled back onto State Road 9 and continued to swerve between the outside and outside center lane, almost resulting in collisions with vehicles traveling in the outside and outside center lanes. I proceeded to activate my emergency lights and sirens in attempt to conduct a traffic stop on the vehicle. The vehicle pulled over onto the right outside shoulder of State Road 9 northbound exit ramp to Palm Beach Lakes Blvd. I then proceeded to walk up to the vehicle. As I spoke to the driver, I immediately detected the odor of an unknown alcoholic beverage was emitting from his breath as he talked. I identified the driver as Juan Luis Abarca by his Florida driver's license: A162432791641 asked the driver if he had been drinking any alcohol beverages previous to driving. He stated he had a couple beers. I also observed the driver's blood shot glassy eyes and very slurred speech. Based on my observations, I requested that Mr. Abarca step out of the vehicle and walk towards the front of my patrol car. The driver agreed to Voluntary perform the Field Sobriety Exercises.

FSEs were conducted on the right shoulder of State Road 9 northbound exit ramp to Palm Beach Lakes Blvd. The ground was free of debris and a red-light pen was used as a stimulus for the Horizontal Gaze Nystagmus. A yellow taped line was used for the Walk and Turn.

Before beginning the exercises, I checked to see if Mr. Abarca was wearing glasses. It was determined that Mr. Abarca was not wearing glasses. I asked Mr. Abarca if he had any injuries or medical conditions that would prevent him from performing the exercises. Mr. Abarca advised he did not have any injuries. Mr. Abarca was instructed to place his feet together and place his hands down at his side. He then was instructed to keep his head still and follow the stimulus with his eyes and his eyes only. He was also instructed to keep looking at the stimulus until told not to. Mr. Abarca verbally indicated he understood all the instructions above.

Horizontal Gaze Nystagmus: Performed on State Road 9

- Equal tracking and equal pupil size.
- During the exercise I observed the defendant with lack of smooth pursuit in both eyes.
- Distinct and sustained nystagmus at maximum deviation in Both eyes
- Onset Nystagmus prior to 45 degrees in both eyes

Walk and Turn: Demonstrated and explained.

The defendant advised he understood the instructions explained.

During the walk and turn I observed

- Unable to maintain balance in the beginning of the exercise
- Driver performed 9 steps (15-16 steps to be exact) forward missing several heal to toe and an improper turn.
- Driver used arms for balance, driver held his arms behind his back during the entire exercise.
- Driver lost balance during turn

One Leg Stand: Demonstrated and explained.

The defendant advised he understood the instructions explained.

During the one leg Stand I observed

- The driver lifted his right foot off the ground
- Driver did not count out loud
- Driver looked up throughout the whole exercise
