The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
The defendant was operating a black 2019 Chevy Suburban, 4 door SUV, Florida tag CIBG06. The defendant drove in a manner in which the vehicle tires crossed onto and/or over painted lane markers several times. The defendant drove at a visually estimated speed of 50 MPH in a properly posted 40 MPH speed limit. A traffic stop was conducted in order to check on the driver's condition to determine if he were sick, tired, distracted, or impaired. The defendant was slow to respond to the indication given to stop, then stopped on the left side of the two way roadway. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant's eyes bloodshot, glassy, and watery. The defendant's face was flushed, and his speech was somewhat and occasionally slurred. The defendant stated that he drank two beers tonight. The defendant was talkative, and nervous. The defendant was slightly unsteady exiting the vehicle. The defendant swayed when standing erect, and chose to keep his feet apart. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and had difficulty following simple instructions. The defendant was arrested for DUI. Post arrest the defendant became argumentative, and accusatorial. The defendant intentionally urinated in his clothing during the reading of the Implied Consent Warnings. The defendant provided breath samples of .156% BrAC and .145% BrAC. The defendant was positively identified by his Florida DL.
