On September 02, 2020, at approximately 11:25pm, I, Trooper Austin Parent ID# 4128 was in service in Palm Beach County, Florida. I was dispatched to the area of northbound I-95 (SR-9) south of Palmetto Park Road (SR-798) of a crash of a vehicle that collided into a marked Florida Highway Patrol in a construction zone. Upon my arrival on scene, I observed a Black in color SUV with damage to the front left and a marked Florida Highway Patrol vehicle with damage to the right rear.

While on scene, I met with Sergeant. Birgit Handzik ID# 383 who was investigating the crash. Sgt. Handzik advised me that the driver was possibly impaired and requested that I conduct a criminal investigation in reference to the driver Driving Under the Influence. After conducting the crash investigation, Sgt. Handzik ID#383 advised the driver that she had concluded the crash investigation and that she was changing hats and that a criminal investigation was going to be conducted by me.

The driver who was identified by his Florida Photo Driver's License as JUAN PABLO ZAFRA, was identified to me as the driver and was standing to the left of his vehicle when I arrived on scene.

I advised ZAFRA that I was moving on to a criminal investigation to determine if he was driving under the Influence. While talking to ZAFRA I observed he was having slight difficulty maintaining his balance, almost falling over while standing as well as walking. I also observed ZAFRA having bloodshot, glassy, watery eyes. I also smelled the odor of an unknown alcoholic beverage emitting from ZAFRA's breath upon him removing his face mask. I then advised ZAFRA of his Miranda rights which he stated verbally he understood at approximately, 11:55pm on September 02, 2020. I then asked ZAFRA with his rights in mind, would he like to answer any

questions, to which he stated "No".

I then explained to ZAFRA that I was going to be requesting him to perform some standardized field sobriety exercises. To which he stated that he did not want to do any exercises, I explained to ZAFRA that if he did not perform the task then I would have to base my decision on the totality of the circumstances. I asked ZAFRA if he understood, to which he stated "Yes". I again asked ZAFRA if he wanted to perform the standardized field sobriety exercises, to which he again stated "No."

I advised ZAFRA that he was being placed under arrest for Driving under the influence. ZAFRA was placed in handcuffs and transported to the Palm Beach County Jail.

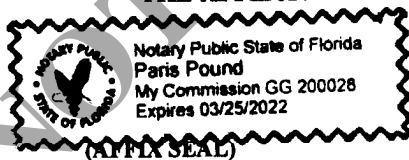
