The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On April 17, 2020 the defendant was operating her 2018 Black Honda Accord bearing Florida license plate#: JIV173 (VIN: 1HGCV1F39JA053718) Northbound on the Veteran's Express Way by Deputy Wehr. Deputy Wehr observed the aforementioned vehicle traveling at an excessive speed, drifting from lane to lane, and straddling the hashed lane divider on both sides of the lane. Deputy Wehr conducted a traffic stop on the vehicle to conduct a welfare check on the driver. Upon contact Deputy Wehr observed the defendant (driver) to have glassy eyes, slurred speech, and observed an open alcoholic beverage on the passenger seat. I met with the defendant and observed her to have glassy eyes, slurred speech, to be disoriented, unsteady on her feet, and I detected the distinct odor of an alcoholic beverage emanating from her breath. The defendant performed standardized field sobriety exercises poorly indicating impairment. Once at Central Breath Testing, after a twenty-minute observation, the defendant provided lawful breath samples showing a breath alcohol concentration of .196/.199. Post Miranda the defendant admitted to consuming three glasses of wine. An inventory search of the vehicle yielded three empty "Twisted Tea" (5% Alcohol by volume, 24 oz) cans. I confirmed the defendant's identity via DAVID.
