<p>On 10/27/2021 at approximately 1330hrs, I responded to the area of 176 E Boca Raton Rd in reference to a assist to Charlotte Police Department (CPD). CPD advised they had information that a suspect in an ongoing investigation from their jurisdiction was possibly coming to the area of Boca Raton at approximately 1400hrs. CPD reported that W/F Julia Grissom (11/04/1997) has an active warrant (21WEA1104750) for Robbery out of Charlotte NC. In addition to her name and dob CPD also provided a physical description of her. Grissom reportedly has purple hair with a thin build. They also stated that she likely would arrive in a dark gray or black Dodge Challenger that they believed to be stolen as well.</p> <p>Per CPD, Grissom reportedly posted on her instagram (Shakergirl797) that she had an appointment at a salon in Boca Raton at 1400hrs. Officers from BRPD set up with view of both entrances to the establishment. At approximately 1355hrs, a W/F with purple hair and same build as described by CPD, approached the south entrance of the building from the south. Ofc. Stepp and I made contact with the female who identified herself as Julia Grissom. I detained Grissom in handcuffs and explained to her that she possibly had a warrant out of NC. BRPD Dispatch confirmed the warrant and Grissom was placed under arrest. See BRPD 2021-012682 for further details regarding the warrant. I asked Grissom how she arrived at the location. She confirmed that she arrived in a black Dodge Challenger which she stated she parked just south of our location.</p> <p>Ofc. Schuss arrived on scene shortly after to conduct a search of Grissom's person. While assisting Ofc. Schuss with collecting Grissom's property, I picked up her purse to place her items in for safe keeping. When I picked up the purse, I noticed a red dodge key fob on the ground underneath. I placed the fob on top of the purse while Ofc. Schuss</p>

<p>continued. Ofc. Bradley arrived shortly after to our location. Ofc. Stepp and I relayed the information provided to us by Grissom in regards to the location of the vehicle she arrived in. Ofc. Bradley later located a black Dodge Challenger parked in front of 165 E Palmetto Park Rd bearing NC TAG HJD4619. Ofc. Stepp then responded to Ofc. Bradley's location with the key located in Grissom's belongings. Ofc. Bradley confirmed that the key fob belonged to this vehicle as the fob successfully unlocked it. Ofc. Bradley reported that he also observed stickers on the windows for the instagram name "Shakergirl797." Ofc. Bradley stated that when he tried to locate a vin number for the vehicle, it appeared that they had either been tampered with and/or removed. Ofc. Bradley also reported that the black exterior of the vehicle was a wrap and that the original color of the vehicle is green. See his report regarding the stolen vehicle recovery (BRPD 2021-012691).</p> <p>The vehicle was later towed to BRPD for further investigation. Det. Bremser of BRPD located the vin of the vehicle which is VIN 2C3CDZL91KH704632. This VIN number was confirmed by BRPD Dispatch as stolen out of Shelby Police Dept in North Carolina. The stolen vehicle is a 2019 green Dodge Challenger that was stolen from Nissan of Shelby on 10/20/2021. See Shelby PD report 20214809 for further details. Prior to speaking with Grissom about the vehicle's status, she was transported to Boca Raton Regional Hospital for medical clearance before being transported to Palm Beach County Jail. While at BRRH, I read Grissom her Miranda warning from a pre printed card. She advised that she understood and agreed to answer my questions.</p> <p>At first, Grissom denied knowledge of the vehicle being stolen. She stated that she paid \$50,000 in cash for the vehicle to a friend. The friend was described as a B/M but could not recall his name. She further stated that she had the title but not with her. It was clear to me that Grissom was being evasive in her responses and lying to me. I explained to her that if she did not want to answer my questions truthfully then she could simply exercise her right to remain silent and speak to an attorney. I explained to her that based on all of the evidence linking her to the vehicle, I was charging her for being in possession of the stolen vehicle as well as the warrant. Grissom became emotional and began to cry. She stated that she wanted to talk but not in front of so many people at the Hospital. After returning from BRRH to the BRPD booking facility, we made contact with Det. Bremser as well as Det. Murphy. Det. Bremser interviewed Grissom and advised her of her rights a second time. See his supplement report for further details.</p> <p>Post Miranda, Grissom admitted that she knew the vehicle was stolen. She stated that she did not steal the vehicle herself but did realize it was stolen. She confirmed that she personally added the dark wrap to the vehicle to disguise the appearance and placed the NC tag on it. Grissom stated that the NC Tag attached to the vehicle is hers, however it is registered in a friend's name. Grissom provided the name attached to the registration. This portion appeared to be truthful based on Det. Bremser's interview.</p>
