The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On October 18, 2019, at approximately 0017 hours, I was traveling eastbound on Interstate 4 at mile marker 12. I observed a white Ford Ranger bearing Florida license plate DYGY74 traveling in the inside lane. The vehicle was traveling with inconsistent speeds ranging from 50 mph to 62 mph in a posted 70 mph zone causing numerous vehicles to have to pass in the center lane. The vehicle continuously weaved within its lane and failed to maintain its lane twice.

Once I made contact with the driver, Ms. Julia Osiecki I noticed her eyes were bloodshot and watery. Her face was flushed and her pupils were dilated. She was slow and lethargic. She fumbled with paperwork while looking for her Driver's license and attempted to hand me her Debit card. I requested her to perform SFSE's and she performed poorly on all exercise's I requested. At approximately 0045 hours, I placed her under arrest for DUI. Due to having an in-car intoxilyzer 8000, I requested her to provide a breath sample and she refused. At approximately 0048 hours, I read implied consent and she refused again. She was transported to the Orient Road Jail
