The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 11/16/2019, at approximately 0143 hours, Deputy Velasquez was traveling south on Nebraska Av N. Deputy Velasquez observed two vehicles stopped in the middle of the road on Nebraska Av N with hazard lights on. Deputy Velasquez observed the front vehicle, a 2014 grey Honda Accord bearing FI tag 7704PG (VIN:4T1BF1FK7EU870667), attempting to reverse into closed parking lot. Deputy Velasquez stopped, and observed the Honda with a completely shredded front passenger tire and a bent rim. Deputy Velasquez observed the defendant seated in the driver seat as the sole occupant of the vehicle. Deputy Velasquez spoke to the defendant, and when he did, he noticed several indicators of impairment. Affiant responded to the scene, detected signs of impairment, and requested the defendant perform field sobriety exercises which the defendant agreed to perform. During the exercises, the defendant showed signs of impairment and was subsequently arrested. Post Miranda, the defendant advised she had struck a raised curb while exiting I275 and popped her tire. Post Implied Consent, the defendant provided a lawful breath sample that resulted in a BAC of .159/.153. The defendant was positively identified via FL DL.
