at approximately 10:26 PM, at 5891 40TH AVE N, in Pinellas County did:

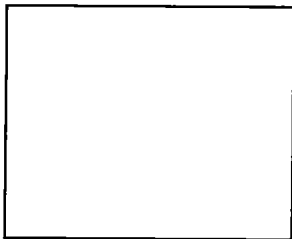
