THE LARGO POLICE DEPARTMENT WAS CALLED BY AN IDENTIFIED WITNESS WHO WAS FOLLOWING A BLUE JEEP BEARING FL TAG 78JQS IN WHICH THEY ADVISED HAD ALMOST REAR ENDED THEM AND WAS FAILING TO MAINTAIN A SINGLE LANE. UPON OFFICERS CONDUCTING AN AREA CHECK FOR THE VEHICLE THEY OBSERVED THE VEHICLE TRAVELING AT A HIGH RATE OF SPEED WHICH WAS PACED AT 83 MPH IN A 45 MPH ZONE AND AGAIN FAILING TO MAINTAIN ITS LANE OF TRAVEL. DUE TO THE OBSERVED TRAFFIC VIOLATIONS AND CONCERNED FOR THE WELFARE OF THE SUBJECT A TRAFFIC STOP WAS CONDUCTED. UPON CONTACT WITH THE DEFENDANT OFFICERS OBSERVED SEVERAL SIGNS OF IMPAIRMENT TO INCLUDE THAT HER EYES WERE BLOOD SHOT AND WATERY. THERE WAS A STRONG ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM HER MOUTH THAT WOULD GROW STRONGER WHEN SHE SPOKE AND SHE ADMITTED TO CONSUMING ALCOHOL PRIOR TO DRIVING. THE DEFENDANT DID CONDUCT SFE'S IN WHICH SEVERAL MORE SIGNS OF IMPAIRMENT WERE OBSERVED AND THE DEFENDANT WAS PLACED INTO CUSTODY FOR DUI. THE DEFENDANT ALSO PROVIDED TWO VALID PBREATH SAMPLES WITH THE RESULTS OF A .184 AND A .189.

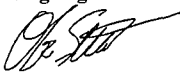

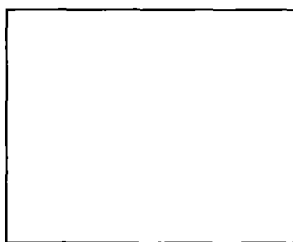
