On 12/12/2020, at approximately 1324 hours I was standing in front of 2843 Lake Worth Road next to my marked PBSO Patrol Vehicle asset #58275, which has external lights and sirens attached. It should be noted that I was wearing my agency issued Class B Uniform, which has "Sheriff" patches affixed to both sleeves, and a five point star badge on the front, clearly identifying me as a law enforcement officer.

I noticed a Silver Toyota Corolla traveling West on Lake Worth Road. The vehicle was traveling in the inside lane. As the vehicle approached the traffic control signal at 2843 Lake Worth Road it made a right turn into the parking lot, cutting off other vehicles and almost causing an accident with other vehicles(CIT#AD XV01E). I conducted a traffic stop on this vehicle. The driver was identified as Julio Cachojil. The vehicle displayed an expired temporary tag of CUT9364. I noticed the Cachajil was sweating heavily and his speech was slurred. I smelled a obvious odor of an unknown alcoholic beverage emitting from his breath and his eyes were glossy and bloodshot.

Based on the driving conduct and physical appearance of Cachajil, I turned the traffic stop over to D/S D'Andrea #29528 for Driving Under the Influence investigation.

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)
D/S TURNER #35197 WAS STANDING IN FRONT OF 2843 LAKE WORTH RD WHEN HE OBSERVED A SILVER IN COLOR TOYOTA (BEARING FLORIDA TEMPORARY TAG OF CUT9364) IN THE INSIDE LANE OF WESTBOUND LAKE WORTH RD APPROACHING THE TRAFFIC CONTROL SIGNAL AT THE ENTRANCE OF PALM BEACH STATE COLLEGE. WHILE OBSERVING THE SILVER IN COLOR TOYOTA APPROACHING THE TRAFFIC CONTROL SIGNAL, THE VEHICLE UNEXPECTEDLY MADE AN IMPROPER RIGHT TURN FROM THE INSIDE LANE FORCING OTHER VEHICLES IN THE OUTSIDE LANE TO SLAM ON THEIR BRAKES. ONCE IN THE PARKING LOT OF WHERE D/S TURNER IS LOCATED, THE SILVER IN COLOR TOYOTA THEN PARKED INTO A PARKING SPOT IN FRONT OF THE BUSINESS. D/S TURNER THEN MADE CONTACT WITH A HISPANIC MALE (LATER IDENTIFIED BY HIS FLORIDA DRIVER'S LICENSE AS JULIO GUSTAVO AJTUN CACHOJIL), WHO WAS IN THE DRIVER SEAT AND SOLE OCCUPANT OF THE VEHICLE. WHILE SPEAKING WITH MR. AJTUN CACHOJIL, HE SMELLED AN OBVIOUS ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE EMITTING FROM HIS BREATH AND NOTICED THAT HIS EYES WERE GLOSSY AND BLOODSHOT. D/S TURNER THEN REQUESTED ME TO THE SCENE.

OBSERVATION OF DRIVER:

I observed that Mr. Ajtun Cachojil was wearing tan pants and a red shirt. I observed Mr. Ajtun Cachojil eyes appeared red and glassy. I observed that he was slurring his words. Mr. Ajtun Cachojil was asked to exit the vehicle to perform field sobriety tasks and he agreed. While exiting the vehicle, Mr. Ajtun Cachojil appeared to be shaky on his feet. Mr. Ajtun Cachojil had difficulty walking in a straight path.

WOULD FOLLOW WITH HIS ENTIRE HEAD INSTEAD OF JUST HIS EYES, WOULD COMPLETELY STOP FOLLOWING MY PEN LIGHT AND LOOK AT ME.

WALK & TURN:

I positioned Mr. Ajtun Cachojil on a bright orange line which was on a smooth and level surface, free of any debris and well lit by the daytime hours of south Florida. I instructed Mr. Ajtun Cachojil to place his left foot on the line and his right foot in front of the left touching heel to toe. I instructed him that he was to keep his hands at his side and stay in this position until I instructed him to do otherwise. I instructed him to walk nine heel to toe steps counting out loud, while watching his feet. On the ninth step he was to keep his front foot on the line and use his back foot, in a series of small steps, to turn around before walking nine heel to toe steps the opposite direction counting out loud and watching his feet. I demonstrated the task while I was verbally instructing him in the proper way to complete the task. During the task, I observed the Mr. Ajtun Cachojil swayed while balancing, started too soon, stops walking to steady self, did not touch heel to toe, stepped off the line multiple amount of times. Used arms to maintain balance (+6"), did not turn properly(turns other way than I explained.) Incorrect number of steps. Could not perform task.

ONE LEG STAND:

I placed Mr. Ajtun Cachojil with his feet together and arms at his side. I demonstrated the task as I verbally instructed him to raise one of his feet approximately six inches off of the ground, point his toe towards my patrol car, look at the raised foot, and count out loud 1001, 1002, 1003 and so on until told to stop. I asked him if he understood the instructions and demonstration I provided. After Mr. Ajtun Cachojil stated he understood my instructions, the task was performed. While Mr. Ajtun Cachojil stood in the instructional position, I observed he started too soon and swayed while standing stationary. While raising his foot he swayed while balancing, put foot down (within 30 seconds).

FINGER TO NOSE:

I placed Mr. Ajtun Cachojil with his feet together and arms at his side with his index fingers pointed. I then instructed and demonstrated to Mr. Ajtun Cachojil to tilt his head back and close his eyes during the exercise. I explained to Mr. Ajtun Cachojil that when I tell him to bring the hand directly upward, touching the tip of his nose with the tip of his index finger and immediately bring his hand back down to his side. I then started the exercise with the following sequence - Right, Left, Right, Left, Left, and Right. I observed Mr. Ajtun Cachojil to use the wrong hand than told to use, would keep going without me telling him right or left, sway while standing stationary, would look in the same direction of what arm I am requesting, unable to touch the tip of his nose.
