The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11/27/2020 at approximately 2141 hours, the defendant was observed by Deputy Trujillo #258678 running a steady red light at the intersection of Hillsborough and Kelly Rd. The defendant traveled approximately 100 mph to the intersection of Kelly Rd and Memorial Hw where Deputy Trujillo conducted a traffic stop. When he made contact with the driver he observed indicators of impairment and the driver/defendant admitted to consuming alcoholic beverages. Upon my contact with the defendant, I observed indicators of impairment and the odor of an alcoholic beverage emitting from the vehicle. During the SFSE's the defendant displayed several more indicators of impairment. Once at CBT, the defendant refused to provide the lawfully requested breath samples after being read implied consent. The defendant was issued DUI citation A950LWE for DUI and UTC AC9Y6SE for failure to obey traffic control device. I also issued him a UTC AE911TE for failure to carry/exhibit DL. The defendant identified himself verbally which was confirmed via DAVID and DHSMV.
