The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: Julissa Largel was driving a black Kia Soul (FL KLTR67) that was stopped for driving without lights. During observation she displayed indicators of impairment to include having red glassy eyes, a drowsy appearance and the distinct odor of an alcoholic beverage on her breath. She displayed additional indicators of impairment during SFST's and was arrested for DUI.
