The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/28/2019, at approximately 0039 hours, I conducted a traffic stop on a 2018 white Ford F-150 (FL tag: AQAA24 / VIN: 1FTEW1EG6JKE12476) for speeding, violating multiple vehicles' right-of-way, and weaving through traffic without the use of a turn signal. Upon making contact with the driver, I immediately observed him to have bloodshot watery eyes, severely slurred speech when speaking to him, delayed response, and a severe odor of an alcoholic beverage on his breath. Field sobriety exercises were refused by the driver, at which time I explained that without him conducting the exercises, I would be forced to base my arrest decision on the totality of circumstances. The driver understand and again, refused to perform exercises. While at CBT, the defendant was read the Implied Consent Warning verbatim, at which time he advised he understood and when asked if he'd be willing to provide breath samples, he stated, "No." The defendant was positively identified via his Florida driver's license.
