Sell stated that she and Moore had been dating for approximately three (3) months and periodically stayed over at each other's residence. Sell provided a sworn recorded statement and stated the following: Moore picked her up earlier in the day and they both went to his residence located at 206 E 25th St. Moore had a close female friend of his over the residence as well. The friend was later identified as Regina Bernhard (DOB 3/29/87, E/F).  
Sell stated that she, Moore and Bernhard were drinking throughout the night. The three later went to Moore's bedroom where they engaged in sexual intimacy. Moore and Sell left out the room and went outside to the patio located in the western part of the residence. While outside, Moore began to get aggressive complaining of Sell's attitude throughout the day. Moore grabbed Sell and threw her to the ground. Sell stated that Moore then head-butt her in the face and with closed fists punched her numerous times. To get Moore off her, Sell bit Moore in the face.  
Moore went inside and refused to give Sell her cell phone. Sell advised that she went to several houses in the street for help in calling 911 but did not receive an answer from any of the homes. After approximately thirty (30) minutes, Moore allowed Sell back in the home. Sell stated that as she walked through the laundry room located in the northwest corner of the home, Moore began to physically attack her again. The physical altercation continued throughout the residence and Moore removed Sell out of the home. Moore then threw Sell's phone at her, which hit her in the top of the head. Sell stayed




Sell had severe swelling around her left eye and bottom lip. Sell also had bruising around her eye and a scratch mark on the right side of her face. Pictures of the injuries were taken and uploaded to evidence.com. Sell was transported to St. Mary's Hospital by Riviera Beach Fire Rescue for her injuries (reference to run #RB20004861. Sell was cleared and released from St. Mary's Hospital with no fractures. Sell was issued a Victim's Rights Brochure.

I made contact with Moore who stated that Sell had too much to drink, began acting belligerent, and bit him in the face. Moore stated that while trying to have Sell leave the house, the two began to tussle. Moore told officers that the injuries to Sell were due to him trying to get her to leave his home after she bit him in the face. Moore had a bite mark with fresh blood to the left side of his face. Pictures of Moore's injuries were taken and uploaded to evidence.com.

Bernhard told officers that she was not present when the physical altercation took place. Bernhard stated she only heard a loud disturbance and could hear Moore yelling at Sell saying, "you bitch".

Based on my investigation, probable cause existed and Moore was placed under arrest for Simple Battery (Domestic) pursuant to FSS 784.03 (1) (A) (1). Moore was transported to the Riviera Beach Police Department for processing and later taken to the Palm Beach County Jail.
