Probable Cause

On February 1, 2020 I was in my patrol car stationary at State Road 9 (interstate 95) north bound south of State Road 706 (Indiantown Road) conducting traffic enforcement on southbound traffic. My patrol car was facing a west direction on the northbound side of State Road 9. As I was observing vehicles traveling southbound on State Road 9, I observed a dark in color vehicle traveling at a high rate of speed in the HOV lane south bound at approximately 100 mph. I proceeded to point my laser S/N: S500269 and aligned the cross hairs towards the front portion of the vehicle. I got a steady reading of 102 mph at 435.8 Ft. I proceeded to merge onto State Road 9 southbound never losing sight of the vehicle. I was able to catch up to the vehicle in the outside center. I proceeded to activate my emergency lights in attempt to conduct traffic stop on the vehicle. The vehicle came into a complete stop on the right outside shoulder of State Road 9 southbound just south of Donald Ross Rd. I confirmed the vehicle to be a red Honda Accord with a tag of JMQR51. I approached the vehicle by the front right passenger side. I proceeded to notify the male driver of the violation he committed and asked for his Driver's license and vehicle information. The driver responded with frustration and notified me that he did not have a operator license on his person and that the vehicle is owned by his fiancé. The driver proceeded to say that he does not have a license from Florida but has one from New-York. I asked the driver to write his first and last name along with his Date of birth on a blank paper which he did.

The driver wrote down Brendan Evans with a date of birth of 9/21/1993. After I received the paper from him, I confirmed with the driver if the information he gave me was correct and he agreed. I proceeded to give his name to our lake worth communication center, but they were unable to find a license or ID associated with that name and date of birth. I went back to the vehicle and asked the driver for a second attempt to confirm his identity. He proceeded to say that his name is Brendan Tyler with a date of birth of 3/2/1991. Dispatch was unable to find any operator license with that name and date of birth. I proceeded to ask the driver for a third time to provide me with his correct name and date of birth. The driver stated that he was nervous and proceeded to write down his correct name of Justin Paul Robert Angot with a DOB: 4/10/1995. Dispatch was finally able to find a driver license out of Florida: A-523-436-95-130-0. His driver license was suspended numerous times. I proceeded to arrest Mr. Angot for obstructing my traffic stop and driving while license suspended. Mr. Angot was transported to the Palm Beach County jail where he was booked.


