The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 The defendant was operating a blue 1990 Honda Civic, 4 door, Florida tag KNWD03. The defendant was stopped for unlawful speed when observed traveling at 51 MPH in a posted 35 MPH construction zone with active construction (moving radar 12540002, front antenna 20400446). The defendant drove in a manner in which he stopped in the roadway without cause, straddled an outer painted lane marker throughout an on-ramp to a limited access roadway, nearly struck a construction barrel, and crossed over painted lane markers. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed, his speech was slightly slurred, and he had a confused look about his face. The defendant denied consuming alcoholic beverages. A 12 pack carton of Bud Light Seltzer was located in the back passenger floorboard, with 4 can left. The defendant was slow to respond to requests, and was easily confused. The defendant unsteady exiting the vehicle, was unsteady on his feet, and swayed while standing. The defendant refused to submit to Field Sobriety Exercises after being advised of possible consequences of refusing. The defendant exhibited signs of impairment, and was arrested for DUI. The defendant refused to submit to a lawful breath test after being advised of the Implied Consent Warnings. The defendant was positively identified by his FL DL.
