On 08/29/2021, at approximately 0135 hours, I was on proactive patrol and traveling west on Ehrlich Rd. I observed a black GMC Sierra (FL tag: QHZN60) to be in front of my patrol vehicle and traveling in the same direction. I observed this vehicle to be weaving within it's lane from left to right. This vehicle struck the dashed white traffic line and straddled the solid white traffic line with it's tires. At the intersection of Ehrlich Rd and Pennington Rd, I conducted a traffic stop on this vehicle to check on the well being of the driver to see whether they were ill, tired or impaired. Upon contact with the defendant, he had slurred speech, bloodshot glassy eyes and the distinct odor of an alcoholic beverage emitted from his breath as he spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI. The defendant then provided two lawful samples of his breath, resulting in a BrAC of .215/.212. The defendant was positively identified via his Florida driver license.
