

(Specifically include facts constituting cause for arrest.)</p> <p>On 03/28/2020 at approximately 1855 hours, I responded to 6151 Riverwalk Ln. in the Town of Jupiter, Palm Beach County, FL at the request of Officer Jurac who had requested assistance. At the time, I was driving an unmarked Jupiter Police Department patrol vehicle (vehicle 1916), I was wearing a JPD uniform clearly identifying myself as a Jupiter Police Officer, and I was wearing my department-issued Axon body camera.</p> <p>Upon arrival, I made contact with Officer Jurac who advised he was speaking with a male later identified as Justo Lamar (w/m; 12/15/1945) outside 6151 Riverwalk Ln., on an unrelated call for service. A brief argument ensued between parties and Lamar walked away, to his vehicle (a white 2003 Toyota sedan bearing FL tag # 192YZL) and left the area. In the process of leaving, the rear passenger bumper of Lamar's vehicle struck the front passenger bumper of a Town of Jupiter marked patrol vehicle (vehicle 1505) which was parked in the parking lot behind the aforementioned Toyota.</p> <p>According to an independent witness, later identified as Maria Colosi (w/f; 05/10/1966), advised Lamar attempted multiple times to exit the parking space and ultimately struck the rear passenger bumper of a gray 2011 Volvo sedan bearing FL tag # KBGF19 which was parked in the space directly next to Lamar's vehicle. The witness further stated that Lamar attempted to shimmy his way out of the parking space and ultimately left the area, traveling south. Colosi stated she observed Lamar as the driver of the vehicle in the crash and later identified him to Law Enforcement on scene. Colosi also provided a BWC recorded witness statement.</p> <p>I collected the information necessary to complete the hit and run investigation and returned to my patrol vehicle. While I was entering the information, I heard Officer Jurac advise that Lamar had returned to the parking lot. I exited my patrol car and observed Lamar driving the aforementioned Toyota, attempting to pull back into the parking space in front of Officer Jurac's vehicle. I also observed that the front passenger fender of Lamar's vehicle had struck the front push bumper of the same police vehicle (vehicle 1505).</p> <p>Due to the fact that Officer Jurac had previously dealt with Lamar, I believe probable cause had been established and I ordered Lamar to stop the vehicle. He did not comply. Lamar's vehicle was traveling slowly in reverse and I continued ordering Lamar to stop the vehicle, smacking my hand on the vehicle's hood as I neared the driver side of the car. Lamar's vehicle ultimately stopped and I ordered him out of the vehicle.</p> <p>Lamar rolled down the window and I opened the vehicle's door from the inside, continuing to order Lamar out. Lamar continued to be non-compliant and was assisted from the driver seat by officers on scene. Lamar was directed to the rear of his vehicle and placed under arrest. Lamar continued his non-compliant behavior and had to be assisted into the rear seat of Officer Jurac's vehicle.</p> <p>After placing Lamar into custody, I attempted to read him his Miranda Warnings and he continued talking over me. Lamar would not advise whether or not he understood his Miranda Warnings and ultimately refused to speak with me.</p> <p>Due to the aforementioned facts resulting from the investigation, I find Probable Cause exists to charge Justo Lamar with Hit and Run - Damage to Property pursuant to FSS 316.063(1).</p>
