The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 03/13/2021, at approximately 2331 hours, I was traveling northbound on the Veterans Expressway in my unmarked patrol vehicle, when I observed a vehicle to be approaching the rear of my vehicle at a high rate of speed. Using my HCSO issued radar unit (moving mode), I measured the speed of the vehicle to be 96 MPH in a posted 60 MPH speed zone. This vehicle then drove past my patrol vehicle. I conducted a traffic stop on a gray Land Rover Range Rover (FL tag: PZXR26) on the off ramp of the Veterans Expressway at the West Waters Ave. Upon contact with the defendant, she had watery glassy eyes and the distinct odor of an alcoholic beverage emitted from her breath as she spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises (SFSE's), which she agreed. During the SFSE's, the defendant showed signs of impairment and was placed under arrest for DUI. Implied consent was read and the defendant then refused to provide a lawful sample of her breath. The defendant was identified via her Florida driver's license.
