On the above-listed date and time at the above-listed location, I was sitting conducting traffic enforcement. I visually observed a Ford van bearing FL tag BRMZ26, traveling south at a high rate of speed. I estimated the vehicle traveling 72 Miles Per Hour mph in a 50 mph posted zone. Using my agency-issued Laser device, Ultra Lyte Lr B, I captured the vehicle speed at 76 MPH. I then activated my emergency equipment, which consist of red/blue lights to conduct a traffic stop on the listed vehicle. I made contact with the defendant who was the sole occupant of the vehicle. While speaking with the defendant, I observed multiple signs of impairment and requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to perform. During the exercises, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant agreed to provide two lawful breath samples to determine her breath alcohol content (BrAC). After a proper 20 minute observation period was conducted, the defendant provided two lawful samples of her breath. First BrAC sample (.192): Second BrAC sample (.193). The defendant received a DUI citation #A4048UE, which reflects the DUI charge. She also received a Uniform Traffic Citation for speeding. The defendant was identified via her Florida Driver's License.
