The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On November 06, 2020 at approximately 1300 hours the defendant willingly and knowingly aimed a Smith and Wesson M&P shield 9mm pistol directly at the victims. The victims were in fear for their lives, and left the scene. The victims were in a marked FEDEX delivery truck and in FEDEX uniform. The victims were there in order to deliver items to the residence when they were approached by the defendant. The vehicle was backed into the driveway because the packages were heavy. The defendant came out and yelled "oh no who the fuck are you." The victims attempted to explain the situation and the defendant yelled "honey go get my gun." The defendant then aimed the weapon at them. The defendant then yelled "you have three seconds to get the fuck off my property," and she loaded a round in the chamber. A individual witness observed the situation and she saw the defendant yelling and with a gun in her right hand. While interviewing the defendant she denied the allegation and that she had no weapon at all at this time. Once the affiants attempted to detain her the defendant attempted to escaped the control of the affiants by pulling away from the affiants and attempting to go back inside. The victim identified the defendant to be the person to have committed the crime through the picture that was taken by the witness and the victims. The defendant and victims do not have a previous relationship. The defendant was further identified via her FLDL. The firearm in question has been removed from the home and placed into the evidence intake department of HCSO
