The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On the listed date and time, Deputy D. Gonzalez #182845, contacted the driver on a traffic stop for careless driving. Upon contact with the driver, the driver emitted an odor of an alcoholic beverage from her breath, she had slurred speech, she had fumbling fingers while retrieving her documents, had bloodshot and watery eyes, and unstable balance. The driver refused to perform Field sobriety exercises after being advised that Field Sobriety exercises are voluntary, and that the exercises confirm or dispel any suspicion of impairment. However, if she refused to perform the following exercises, she could be arrested for suspicion of DUI based on the totality of the circumstances, and that her refusal to perform the requested exercises will be used against her in a court of law. The driver acknowledged the warning and she was arrested for DUI based on the totality of the circumstances. The driver refused breath test after Implied Consent warning was read and understood. The driver invoked her right to remain silent after being advised of her rights. The driver was identified via a valid Florida DL.
