On December 15, 2019 at approximately 10:17 am, I Trooper Michael Corrao responded to a suspicious vehicle call on the I-275 (SR 93) exit ramp at MM 39. Upon arrival, I observed two rangers talking with Fire Rescue and black Nissan pickup truck on the outside shoulder (Black Nissan pickup bearing Florida Tag #974QTB). One of the Road Ranger's (Willis Guzman) advised he located the pickup truck stopped in the outside northbound lane of the exit ramp. Mr. Guzman advised that the vehicle was in park and the driver was utilizing her phone. Mr. Guzman then advised he had the driver move the vehicle off the road to its current position on the outside shoulder. Mr. Guzman advised that as he was interacting with the driver, she became erratic. Mr. Guzman advised the driver was laying on the ground and making weird comments.

I then approached the pickup and observed a female sleeping in the driver's seat (Later identified as Kamla Grimmer by her Florida Driver's license on NCIC/FCIC and DAVID). The pickup truck had the keys in the ignition and the vehicle was running. Ms. Grimmer was very disoriented and unaware of the situation at hand. Ms. Grimmer could not answer basic questions. Ms. Grimmer advised the day was December 2015.

Fire Rescue checked and cleared Ms. Grimmer. Ms. Grimmer also refused to be transported. **CLERK OF CIRCUIT COURT**

While talking to Ms. Grimmer, I smelled the strong odor of alcoholic beverages coming from her facial region. She was unsteady on her feet and was mumbling her words. Ms. Grimmer's eyes were bloodshot and watery. Ms. Grimmer was very lethargic and sleepy. Ms. Grimmer advised she was coming from Ybor City and heading towards Spring Hill. Ms. Grimmer advised she had two tequila shots and two Bud Light beers.

I asked Ms. Grimmer if she would perform field sobriety exercises and which she complied. I then took Ms. Grimmer off the interstate to 5401 W Kennedy Blvd Tampa, FL 33609. Ms. Grimmer performed poorly on field sobriety exercises. Based on field sobriety exercises and all my observations, Ms. Grimmer's normal faculties were impaired to the point to where she could not operate a motor vehicle and was arrested for DUI.

Ms. Grimmer was then transported to Hillsborough County Jail where she provided two breath samples after a twenty-minute observation period (.241 and .231). Ms. Grimmer was then booked into Hillsborough County Jail for Driving Under the Influence.

Trooper Albert Chu had the pickup towed from the scene. Trooper Albert Chu advised he located an eight pack of Bud Light located in the vehicle. Trooper Chu advised three of the eight 16oz beers were missing.
