The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a silver 2016 Volvo XC-90 SUV (NY TAG #JBH1103) northbound on Howard Av N from Kennedy Blvd W at a high rate of speed, which I visually estimated to be at about 70 MPH. After catching up to the vehicle, I paced behind it for several blocks and observed a speed of 70 MPH on my speedometer. This section of Howard Av N is a posted 40 MPH speed zone. During the traffic stop for the driving infraction, the defendant exhibited several clues of impairment, to include: Watery/bloodshot eyes, slurred speech, confusion with her paperwork, and had an odor of an alcoholic beverage stemming from her breath. She was arrested for DUI following a poor performance on SFSEs. While at CBT, the defendant was read Implied Consent, and provided two valid breath samples, measuring .058/.060 BrAC. Due to her level of impairment not being consistent with her breath results, I requested a urine sample; however the defendant refused to provide it.
