The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: At the listed date and time, a traffic stop was conducting on a black/red Ford Fusion (FL #Y923KG / VIN: 3FAHP07Z99R126007), due to the windshield being cracked and both sideview mirrors were missing. The driver, Jorge Rivas, gave verbal consent for a search of his vehicle to be conducted. When the front passenger/defendant exited her seat, I observed she had a multicolored purse and small black zip backpack between her feet. While the defendant was outside of the vehicle, she notified Deputies she had a glass pipe in her purse. A search of her purse was conducted and one glass pipe with residue on it was located. Upon searching the defendant's black backpack, a small clear plastic q-tip box was located. Inside of the q-tip box was a small clear baggie containing a crystal substance. Using an HCSO issued field reagent drug test kit, the crystal substance tested positive for amphetamine. The defendant spontaneously stated the black backpack was hers. The defendant verbally identified herself and I verified her identity via her DHSMV photograph. Due to the defendant's felony charge, she was not APAD eligible.
